

# NASSAU COUNTY POLICE DEPARTMENT SCHOOL RESOURCE INFORMATION



#### **CALLS FOR SERVICE:**

All calls for service including emergencies and requests for investigation and/or report should be initiated through 911.

This allows for appropriate documentation/assignment of the call to patrol officers by our Communications Bureau (CB).

(Requests for Police response should not be made by direct calls to the individual precincts.)

# SCHOOL LOCKDOWN DRILLS

All school lockdown drills utilizing panic buttons associated with an alarm company or the RAVE system must be coordinated with members of the NCPD. These drills should be scheduled in advance to avoid unintentional consequences. A school official will contact either their Precinct Problem Oriented Police (POP) officers and/or NCPD Homeland Security.

### **NCPD RAVE SYSTEM:**

RAVE Testing will not be conducted without prior approval of the NCPD. The requesting school district will ensure that all registered participants have been notified of the intended test date / time. Members of NCPD Homeland Security will coordinate the test and will give advance notice to the CB Operations Desk prior to the test. At the time of the test, the NCPD Homeland Security Police Officer will call CB Operations to confirm that there are no major incidents going on that would impede the test.

#### **THIRD PARTY PANIC ALARMS:**

When testing third party panic alarms the test should be done in conjunction with Precinct Problem Oriented Police (POP) officers. The on-site POP Officer contacts CB Operations Desk to advise that a drill is being conducted and to verify that no further NCPD resources are needed. CB Supervisor will advise the call takers that a test is being conducted in the event that 911 is notified. POP will advise CB when the drill is concluded.
